Petitioner Blue Street Capital, LLC (Blue Street) has filed a petition for reinstatement of its California Financing Law license (Petition). Blue Street's license was revoked by the Commissioner of Financial Protection and Innovation (Commissioner) on April 19, 2022.

On June 24, 2024, the Commissioner notified the Attorney General of the filing of the Petition and gave the parties until July 24, 2024 to present written argument or supporting documentation with respect to the Petition.

ORDER CONDITIONALLY GRANTING PETITION FOR REINSTATEMENT

1 On July 31, 2024, the Commissioner granted the Petition on the condition that Blue Street did
2 the following no later than 45 days after the date of the Order:

- 3 1. Pay a \$1,000 penalty for each of the fifty (50) loans and leases with \$1 buyout made while
4 unlicensed in violation of Financial Code section 22100, subdivision (a), for a total of
5 \$50,000.

6 The Commissioner finds that Blue Street has complied with all conditions for reinstatement
7 of its license and is otherwise fit to engage in the business of finance lending or brokering.

8 THEREFORE, IT IS ORDERED that the Petition is granted and Blue Street Capital, LLC's
9 CFL license is reinstated, effective as of the date of this Order.
