On July 31, 2024, the Commissioner granted the Petition on the condition that Blue Street did the following no later than 45 days after the date of the Order:

1. Pay a \$1,000 penalty for each of the fifty (50) loans and leases with \$1 buyout made while unlicensed in violation of Financial Code section 22100, subdivision (a), for a total of \$50,000.

The Commissioner finds that Blue Street has complied with all conditions for reinstatement of its license and is otherwise fit to engage in the business of finance lending or brokering.

THEREFORE, IT IS ORDERED that the Petition is granted and Blue Street Capital, LLC's CFL license is reinstated, effective as of the date of this Order.
