CONTROL OF ANY INVESTMENT  
ADVISER, BROKER-DEALER OR  
COMMODITY ADVISER

22 1. On August 5, 2024, the Commissioner issued an accusation in support of order to bar  
23 Andrew L. Penn from any position of employment, management, or control of any investment  
24 adviser, broker-dealer, or commodity adviser (Accusation), pursuant to Corporations Code section  
25 25232.1.

26 2. On August 23, 2024, Robinson Services and Tafara Robinson (collectively,  
27 "Robinson") were served with the Accusation, Commissioner's notice of intention to issue the  
28 aforementioned Accusation (Notice of Intention), Statement to Respondents, a Notice of Defense,

1 and Government Code sections 11507.5, 11507.6, and 11507.7.

2 3. The Notice of Intention specifically informed the Respondent that unless a request for  
3 a hearing, as evidenced by the mailing or delivery of the Notice of Defense, was received by the  
4 Commissioner within 30 days after the Accusation was served on Robinson, the bar order may be  
5 entered at any time thereafter without a hearing. To date, no request for a hearing has been made by  
6 Robinson.

7 NOW GOOD CAUSE APPEARING THEREFORE, IT IS ORDERED that Tafara Robinson is  
8 hereby barred from any position of employment, management or control of any investment adviser,  
9 broker-dealer, or commodity adviser effective this date.

10 This Order is necessary, in the public interest, for the protection of investors, and consistent  
11 with the purposes, policies, and provisions of the Corporate Securities Law.
