20 Department of Financial Protection and Innovation, on November 15, 2024, issued a Statement in  
21 Support of Stop Order Denying Effectiveness of Franchise Registration Application for application  
22 no. 31031 (Statement) to Anchored Tiny Homes Franchising, LLC, doing business as Anchored  
23 Tiny Homes (“ATH”). The Statement is incorporated herein by reference.

24 Based on the findings contained in the Statement, the Commissioner has determined that an  
25 order should be issued pursuant to Corporations Code section 31115, subdivisions (a) and (d)(4),  
26 denying the effectiveness of the franchise registration application no. 31031 filed on or around  
27 April 8, 2024, by ATH.
