

## THE STATE BANKING SYSTEM IN 2024

### Commercial Banks

On January 1, 2024, there were 98 state-chartered commercial banks. During the year, one banks opened, four banks merged out of existence, one bank converted to national charter and one bank voluntarily surrendered its license bringing the total number of state-chartered commercial banks to 93 at year-end.
