ssioner of Financial Protection and Innovation (Commissioner) finds:

- nsula Equity Capital LLC (PEC) is a Wyoming limited liability company with its usiness at 2055 Birch Avenue, San Carlos, CA 94070.
- anuary 11, 2024, the Commissioner issued an investment adviser certificate to stration Depository No. 329144)¹, pursuant to the Corporate Securities Law of er Financial Code section 326(a), the Commissioner is authorized to administer and enforce the provisions of the CSL and the regulations promulgated thereunder³.
- Ryan Taleghani (Taleghani) (CRD Number 6554123) is the 100% owner and the sole 3. investment adviser representative of PEC.
- 4. On or about May 13, 2025, the Commissioner attempted to commence a routine examination of PEC under section 25241. In order to begin the examination, the Commissioner

called and emailed PEC using the telephone number and email address that PEC had on record with 2 the Commissioner. On or about May 20, 2025, the Commissioner sent a follow-up letter by certified 3 mail, return receipt. PEC did not respond to the Commissioner's contact attempts. 5. 4 Under section 25242(b), the Commissioner may summarily revoke the certificate of an investment adviser if the investment adviser is no longer in existence, has ceased to do business, 6 or cannot be located after reasonable search. 7 NOW, BASED UPON THE FOREGOING AND GOOD CAUSE APPEARING, IT IS 8

HEREBY ORDERED under section 25242(b), that the investment adviser certificate of Peninsula Equity Capital LLC is revoked. This Order is effective immediately. Peninsula Equity Capital LLC is precluded from soliciting or facilitating new business, including existing clients. The Commissioner finds this action is appropriate, in the public interest, necessary for the protection of investors, and consistent with the purposes fairly intended by the CSL.
