21 The Commissioner of Financial Protection and Innovation (Commissioner) finds that:
22 Pacific Private Money Inc. (Respondent) did not file its Annual Report as required by
23 Financial Code section 22159.

24 The Commissioner provided notice to Respondent of this violation on March 17, 2026 and
25 again on March 27, 2026.

26 The Commissioner notified Respondent, by sending such notices to the email address
27 Respondent was required to create and monitor for communications from the Commissioner
28 (Designated Email Address) in accordance with the Commissioner’s Order on Electronic

1 Communications, dated November 22, 2013, California Code of Regulations, title 10, section
2 1422.5, and Financial Code section 331.5. The notices warned that the filings were delinquent, and
3 that the Commissioner could summarily revoke the license for failing to file pursuant to Financial
4 Code section 22715.

5 Financial Code section 22715 provides that:

6 The Commissioner may by order summarily suspend or revoke the
7 license of any licensee if that person fails to file the report required by
8 Section 22159 within 10 days after notice by the Commissioner that
9 such report is due and not filed. If, after an order is made, a request for
10 hearing is filed in writing within 30 days and the hearing is not held
within 60 days thereafter, the order is deemed rescinded as of its
effective date.

11 THEREFORE, GOOD CAUSE APPEARING, Respondent’s California Financing Law
12 license is hereby revoked as of the date of this Order, pursuant to Financial Code section 22715.

13 This order controls and overrides the Order Suspending Respondent’s CFL License issued
14 on March 16, 2026.

15 Respondent is hereby ordered and directed to discontinue making or brokering any loan
16 made pursuant to the California Financing Law. (Financial Code §22000 et seq.)
