10 **DESIST AND REFRAIN ORDER**
11 **(For violations of section 25110 of the Corporations Code)**

12 The Commissioner of Corporations finds that:

13 1. International Innovative Investments, LLC (“International”) is a limited liability
14 company organized under the laws of Nevada on February 1, 2011. Its status is currently revoked.
15 Its last known address is 65 Pine Ave. #815, Long Beach, CA 90802.

16 2. Global Healthcare (“Global”) is an entity of unknown form. Its last known address is
17 also 65 Pine Ave. #815, Long Beach, CA 90802.

18 3. Jeremy Barnett, also known as Jeremiah Barnett (“Barnett”), is the founder and
19 control person of both International and Global. Barnett’s last known business address is 65 Pine
20 Ave. #815, Long Beach, CA 90802.

21 4. Beginning in 2010 or earlier, International, Global, and Barnett offered and sold
22 securities in the form of promissory notes issued by International and Global to residents of
23 California and elsewhere. The promissory notes provided that interest would be paid monthly to the
24 investor.

25 5. Barnett signed documents stating that he would “personally guarantee” payment under
26 the promissory notes. However, International and Global have stopped making interest payments to
27 investors and Barnett has not responded to investors.

6. These securities were offered or sold in this state in issuer transactions. The Department of Corporations has not issued a permit or other form of qualification authorizing any person to offer or sell these securities in this state.

7. These securities were offered and sold to people with whom International, Global, and Barnett did not have a preexisting relationship.

Based upon the foregoing findings, the Commissioner of Corporations is of the opinion that the promissory notes that are being or have been offered or sold by International Innovative Investments, LLC; Global Healthcare; and Jeremy Barnett, also known as Jeremiah Barnett, are securities subject to qualification under the California Corporate Securities Law of 1968 and are being or have been offered or sold without being qualified in violation of Corporations Code section 25110. Pursuant to Corporations Code section 25532, International Innovative Investments, LLC; Global Healthcare; and Jeremy Barnett, also known as Jeremiah Barnett, are hereby ordered to desist and refrain from the further offer or sale in the State of California of securities, including but not limited to promissory notes, unless and until qualification has been made under the law or unless exempt.

This Order is necessary, in the public interest, for the protection of investors and consistent with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
