DESIST AND REFRAIN ORDER
(For violations of section 25110 of the Corporations Code)

The California Corporations Commissioner finds that:

1. At all relevant times, Idle Hand Productions, LLC is an entity located at 1127 Mannheim Road, Suite 301, Westchester, Illinois 60154.
2. At all relevant times, The Legend of Mary Worth is a movie production produced by Idle Hand Productions, LLC and operating a website at www.maryworththemovie.com.
3. At all relevant times, Joseph Domingo is the executive producer for Idle Hand Productions, LLC and contact person for investors inquiring about investing in The Legend of Mary Worth.
4. Beginning in or about September 2005 to the present, Joseph Domingo, Idle Hand Productions, LLC, and The Legend of Mary Worth offered or sold securities in the State of California in the form of equity shares in The Legend of Mary Worth, in a public offering on the website www.surfview.com.

1 5. In or about December 2005 a California investor contacted Joseph Domingo in response to
2 the advertisement seeking active investors for The Legend of Mary Worth on the Surview website.
3 Joseph Domingo sent offering materials stating that the investor would receive “115% recoupment of
4 the initial investment and 50% split with Idle Hand Productions, LLC after recoupment.”

6 6. The Department of Corporations has not issued a permit or other form of qualification
7 authorizing any person to offer and sell these securities in this state.

9 Based upon the foregoing findings, the California Corporations Commissioner is of the
10 opinion that the equity shares in The Legend of Mary Worth are securities subject to qualification
11 under the California Corporate Securities Law of 1968 and are being or have been offered or sold
12 without being qualified in violation of Corporations Code section 25110. Pursuant to section 25532
13 of the Corporate Securities Law of 1968, Joseph Domingo, Idle Hand Productions, LLC, and The
14 Legend of Mary Worth are hereby ordered to desist and refrain from the further offer or sale in the
15 State of California of securities, including but not limited to equity shares, unless and until
16 qualification has been made under the law.

18 This Order is necessary, in the public interest, for the protection of investors and consistent
19 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
