**DESIST AND REFRAIN ORDER**  
**(For violations of section 25110 of the Corporations Code)**

The California Corporations Commissioner finds that:

1. At all relevant times, LX Pictures (“LX”) is, or was, an entity whose legal status is unknown. LX’s last known business address is 5062 Lankershim Blvd., #3026, North Hollywood, California 91601. LX is purportedly an independent film production company, which maintains a website at <http://www.EpitaphTheMovie.com>.

2. At all relevant times, George Minasyan a.k.a George Mana a.k.a Minasyan Georgiy (“Minasyan”) is, or was, an individual with a business address of 5062 Lankershim Boulevard, #3026, North Hollywood, California 91601. At all relevant times herein, Minasyan is, or was, a film producer at LX.

3. In or about February 29, 2008, and through means of general solicitation, including online advertisements posted on <http://www.MySpace.com>, <http://www.raisecapital.com>, and <http://minneapolis.craigslist.org>, LX and Minasyan offered to sell or sold, and continue to offer to sell or sell securities in the form of investment contracts or stock to the public, including California residents. LX, and Minasyan’s advisements state that they are “... seeking \$300,000 of investment. 300% ROI...”

5. The purported purpose of the offerings is to raise funds for further investment in LX and Minasyan’s planned film production.

1           6.       These securities were offered or sold in this state in issuer transactions. The  
2 Department of Corporations has not issued a permit or other form of qualification authorizing any  
3 person to offer or sell these securities in this state.

4           Based upon the foregoing findings, the California Corporations Commissioner is of the  
5 opinion that securities in the form of investment contracts or stock that were offered or sold, are  
6 securities subject to qualification under the California Corporate Securities Law of 1968 and are  
7 being or have been offered or sold without being qualified in violation of Corporations Code section  
8 25110. Pursuant to section 25532 of the Corporate Securities Law of 1968, LX Pictures, and George  
9 Minasyan a.k.a George Mana a.k.a Minasyan Georgiy are hereby ordered to desist and refrain from  
10 the further offer or sale in the State of California of securities, including but not limited to,  
11 investment contracts or stock unless and until qualification has been made under the law or unless  
12 exempt.

13           This Order is necessary, in the public interest, for the protection of investors and consistent  
14 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
