DESIST AND REFRAIN ORDER

(For violations of sections 17200, 17210.2 and 17403 of the California Financial Code)

The California Corporations Commissioner finds that:

1. One-ecommerce.com and Clark Douglas have engaged in business as escrow agents by advertising escrow services over the Internet at www.one-ecommerce.com, from 2000 to the present as follows:

a) One-ecommerce.com represents on its website that the process works as follows:

The buyer and seller agree to the terms of the transaction. The buyer submits a payment to One-ecommerce.com, which verifies the payment. One-ecommerce.com notifies the seller to ship its merchandise and then verifies that the buyer receives the shipment. The buyer accepts the goods. One-ecommerce.com then pays the seller and the transaction is complete.

b) One-ecommerce.com claims to protect both the buyer and the seller from fraud with this process.

c) One-ecommerce.com and Clark Douglas have represented themselves to be licensed escrow agents by advertising that they hold Department of Corporations escrow agents' license number 963-2060. In fact, the Department of Corporations issued escrow license number

1 963-2060 to Escrow Link, Inc., in La Mirada, California. However, One-ecommerce.com is not a
2 website of Escrow Link, Inc.

3 2. Neither One-ecommerce.com nor Clark Douglas has been issued a license from the
4 Commissioner authorizing either to conduct business as an escrow agent, as required by California
5 Financial Code section 17200.

6 3. Neither One-ecommerce.com nor Clark Douglas is exempt from the licensing
7 requirements of Section 17200.

8 4. Neither One-ecommerce.com nor Clark Douglas has been issued a license from the
9 Commissioner authorizing either to use words indicating that it is in the escrow business, as required
10 by California Financial Code section 17403.

11 5. One-ecommerce.com and Clark Douglas have disseminated or caused to be disseminated
12 false, misleading and/or deceptive statements or representations that they are licensed by the
13 Department of Corporations.

14 Based upon the foregoing findings, the California Corporations Commissioner is of the
15 opinion that One-ecommerce.com and Clark Douglas, and their officers, directors, partners, agents,
16 employees and/or servants are in violation of California Financial Code sections 17200, 17210.2(a)
17 and 17403(a). Pursuant to California Financial Code section 17416, One-ecommerce.com and Clark
18 Douglas are hereby ordered to desist and refrain from engaging in the business of receiving escrows
19 for deposit or delivery without first obtaining a license from the Commissioner. Pursuant to
20 California Financial Code section 17403(b), One-ecommerce.com and Clark Douglas are further
21 ordered to immediately desist and refrain from issuing, circulating, or publishing any advertisement
22 by means of any communication, including any website, or making use of or circulating any
23 letterheads, billheads, blank notes, blank receipts, blank escrow instructions, certificates, circulars, or
24 any written or printed paper containing any fictitious or corporate name or other words indicating that
25 it is in the escrow business. Pursuant to California Financial Code section 17210.2(c), One-
26 ecommerce.com and Clark Douglas are further ordered to immediately desist and refrain from
27 disseminating, or causing or permitting to be disseminated, in any manner whatsoever, any statement
28 or representation which is false, misleading, or deceptive, or which omits to state material

1 information, or which refers to the supervision of that agent by the State of California or any
2 department or official thereof.

3 This Order is necessary, in the public interest, for the protection of investors and consistent
4 with the purposes, policies and provisions of the California Escrow Law. This order shall remain in
5 full force and effect until further order of the California Corporations Commissioner.
