DESIST AND REFRAIN ORDER
(For violations of section 25110 and 25401 of the Corporations Code)

The California Corporations Commissioner finds that:

1. Nelson Salomon Faisal ("Faisal") is an individual whose last known address is 313 South Brand Boulevard, San Fernando, California, 91340.
2. Salomon Faisal Financial Corp. ("Salomon Financial") is a California corporation whose last known address is 313 South Brand Boulevard, San Fernando, California, 91340.
3. Beginning in or about May 2006, Faisal and Salomon Financial offered and sold securities in the form of investment contracts. The purported purpose of the offering was to sell equity ownership interests in WFI Investment.
4. Beginning in or about May 2006, Faisal and Salomon Financial offered or sold the above described securities in the State of California to unaccredited investors.
5. In connection with the offer and sale of these securities, Faisal and Salomon Financial misrepresented material facts. These misrepresentations included, but are not limited to the following:
 - a. Faisal and Salomon Financial represented that WFI Investment was an existing entity;
 - b. Faisal and Salomon Financial represented that an investment into Salomon Investments would make the investor a 10% equity owner in WFI Investment.

1 6. These securities were offered or sold in this state in issuer transactions. The Department of
2 Corporations has not issued a permit or other form of qualification authorizing Nelson Salomon
3 Faisal or Salomon Faisal Financial Corp. to offer and sell these securities in this state.

5 Based on the foregoing findings, the California Corporations Commissioner is of the opinion
6 that the investment contracts offered and/or sold by Nelson Salomon Faisal and Salomon Faisal
7 Financial Corp. are securities subject to qualification under the California Corporations Code and are
8 being or have been offered or sold without being qualified or exempt, in violation of Section 25110
9 of the California Corporations Code.

10 Further, the California Corporations Commissioner is of the opinion that the securities offered
11 by Nelson Salomon Faisal and Salomon Faisal Financial Corp. were offered and sold in this state by
12 means of written or oral communications that included untrue statements of material fact or omitted
13 to state material facts necessary in order to make the statements made, in the light of the
14 circumstances under which they were made, not misleading, in violation of section 25401 of the
15 California Corporations Code.

16 Pursuant to Section 25532 of the California Corporations Code, Nelson Salomon Faisal and
17 Salomon Faisal Financial Corp. are hereby ordered to desist and refrain from the further offer or sale
18 in the State of California of securities, including, but not limited to investment contracts, unless and
19 until qualification has been made under said law or unless exempt.

20 Pursuant to Section 25532 of the California Corporations Code, Nelson Salomon Faisal and
21 Salomon Faisal Financial Corp. are hereby ordered to desist and refrain from offering or selling any
22 security in the State of California, including, but not limited to investment contracts by means of any
23 written or oral communication which includes an untrue statement of a material fact or omits to state
24 a material fact necessary in order to make the statements made, in the light of the circumstances
25 under which they were made, not misleading.
