11 DESIST AND REFRAIN ORDER
12 (For violations of section 25110 of the Corporations Code)

13 The California Corporations Commissioner finds that:

14 1. tmdcasting.com (“TMD”) is, and was at all relevant times herein, an entity of unknown
15 origin that operates a website on the World Wide Web at www.tmdcasting.com, and has a post office
16 box at PO BOX 61359, Sunnyvale, CA 94088.

17 2. Nino Joseph Mihilli (“Mihilli”) is, and was at all relevant times herein, the administrative
18 contact for www.tmdcasting.com, and listed as the Writer and Executive Producer at TMD. Mihilli is
19 located at 731 South Arizona Avenue, Chandler, AZ 85225, and 2015 W. Vineyard Rd., Phoenix, AZ
20 85041.

21 3. Beginning at least as early as 2010, TMD and Mihilli offered securities in the form of
22 investment contracts representing units and seed capital for the making of television and film
23 projects.

24 4. The purported purpose of the offerings is to invest in certain television and feature film
25 projects.

26 5. According to TMD, all “investors will be in a pool that will receive Fifty Percent (50%) of
27 the profits of the movie being sold to a distributor.” TMD claims that its current investors include
28 T47 Group, LLC, a limited liability company located at 2015 W. Vineyard Rd., Phoenix, AZ 85041.
Mihilli is, and was at all relevant times herein, an officer of T47 Group, LLC.

1 6. Mihilli offered at least one California resident investment opportunities to provide seed
2 capital for La Carniceria, a television project, and to provide seed capital for Resurrection, a feature
3 film.

4 7. The investment contracts are securities pursuant to California Corporations Code section
5 25019.

6 8. These securities were offered in this state in issuer transactions. The Department of
7 Corporations has not issued a permit or other form of qualification authorizing any person to offer or
8 sell these securities in this state.

9 Based upon the foregoing findings, the California Corporations Commissioner is of the
10 opinion that the investment contracts are securities subject to qualification under the California
11 Corporate Securities Law of 1968 and are being or have been offered without being qualified in
12 violation of California Corporations Code section 25110.

13 Pursuant to the California Corporations Code section 25532, Nino Joseph Mihilli and
14 tmdcasting.com are hereby ordered to desist and refrain from the offer or sale of securities in the
15 State of California, including, but not limited to investment contracts, unless and until qualification
16 has been made under said law or unless exempt.

17 This Order is necessary, in the public interest, for the protection of investors and consistent
18 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
