DESIST AND REFRAIN ORDER
(For violations of section 25110 of the Corporations Code)

The California Corporations Commissioner finds that:

1. Michael R. Ussery, Jr. aka Michael White (hereinafter "Ussery") is an individual residing in California at various locations, including 9321 Pioneer Street, Stockton, CA 95212.

2. Catherine A. Sims ("Sims") is an individual residing or doing business in California at various addresses, including 6333 Pacific Av., Ste. 400, Stockton, CA. Sims has obtained numerous different business licenses in and about the Stockton area, including Bookings Unlimited, Madea & Co., M & M Entertainment, and MJB Entertainment, all allegedly doing business at the address of 6333 Pacific Av., Suite 400, Stockton, CA.

3. In or about 2006, Ussery offered and sold securities in California in the form of profit-sharing agreements or investment contracts to investors. These have been described as participation

1 by the investor in the promotion of music performances by musical artists with the expectation of
2 profits from the sale of tickets to the public. Ussery, using the name Michael White, has represented
3 that his company, Bookings Unlimited, has experience in the music promotion field and can assist the
4 investor to get started in the field of music promotion. Money from investors has been paid to an
5 account in the name of "Bookings Unlimited," one of the business names held by Sims. In some
6 cases, Sims represented she herself would perform at music concerts, but failed to appear and
7 perform as promised.

8 4. These securities were offered and sold in this state. The Department of Corporations has
9 not issued a permit or other form of qualification authorizing any person to offer and sell these
10 securities in this state.

11 Based upon the foregoing findings, the California Corporations Commissioner is of the
12 opinion that the profit-sharing agreements and investment contracts described above are securities
13 subject to qualification under the California Corporate Securities Law of 1968 (California
14 Corporations Code section 25000 et seq.) and are being or have been offered or sold without being
15 qualified in violation of Corporations Code section 25110. Pursuant to section 25532 of the
16 Corporate Securities Law of 1968, Michael R. Ussery, Jr. aka Michael White, Catherine A. Sims, and
17 Bookings Unlimited are hereby ordered to desist and refrain from the further offer or sale in the State
18 of California of securities, including but not limited to profit-sharing agreements and investment
19 contracts, unless and until qualification has been made under the law or unless exempt.

20 This Order is necessary, in the public interest, for the protection of investors and consistent
21 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
