DESIST AND REFRAIN ORDER (For violations of Financial Code section 22100)

The Commissioner of Business Oversight (Commissioner) finds that:

- 1. At all relevant times, A-M Auto Sales & Lease, Inc. also doing business as A-M Auto Buy & Loan 4 Titles, Inc. (A-M Auto) was a California corporation with its principal place of business at 10161 Bolsa Avenue, Suite #208A, Westminster, California, 92683.
- 2. At all relevant times, Ali Derakhshanian (Derakhshanian) was the owner and president of A-M Auto.
- 3. At all relevant times, A-M Auto engaged in the business of a finance lender through at least December 2012 by offering auto title loans to the public at its Westminster location.
- 4. The Commissioner has not issued a license to A-M Auto authorizing them to engage in the business of a finance lender under the California Finance Lenders Law (CFLL). A-M Auto is also not exempt from the licensing requirements of the CFLL.

Based on the foregoing findings, the Commissioner of Business Oversight is of the opinion that A-M Auto Sales & Lease, Inc., also doing business as A-M Auto Buy & Loan 4 Titles, has engaged in the business of a finance lender without a license in violation of Financial Code section 22100. Pursuant to Financial Code section 22712, A-M Auto Sales & Lease, Inc., also doing business as A-M Auto Buy & Loan 4 Titles is hereby ordered to desist and refrain from engaging in the business of a finance lender in the State of California without first obtaining a license from the Commissioner, or otherwise being exempt.

1	This order is necessary, in the public interest, for the protection of consumers and is		
2	consistent with the purposes, policies, and provisions of the California Finance Lenders Law.		
3	Financial Code section 22712 provides in pertinent part: Whenever, in the opinion of the commissioner, any person is engaged in business as a broker or finance lender, as defined in this division, without a license from the commissioner the commissioner may order that person to desist and to refrain from engaging in the business If, after the order is made, a written request for a hearing is filed and no hearing is held within 30 days thereafter, the order is rescinded.
