NOW GOOD CAUSE APPEARING THEREFORE, it is hereby ordered that effectiveness of the franchise registration submitted by ATNcare Franchising, LLC (D/B/A Go Telecare) is denied. The issuance of this order is necessary, in the public interest, for the protection of investors and is consistent with the purposes, policies, and provisions of the California Franchise Investment Law.
