23 Wayne Strumpfer, the Acting California Corporations Commissioner ("Commissioner") of
24 the Department of Corporations ("Department") finds that:

25 All Weather Portfolio Management, Inc. ("All Weather") has violated certain regulations
26 promulgated pursuant to the Corporate Securities Law of 1968 (Corp. Code § 25000 et seq.). All
27 Weather has violated the following sections of California Code of Regulations, title 10: section
28 260.237.1, subdivision (a)(2), by failing to maintain required tangible net capital balances; section

1 260.241.2, subdivision (a), by failing to timely file required annual financial reports with the
2 Commissioner; section 260.241.2, subdivisions (d)(2)(A)(1), (d)(2)(B) and (d)(3), by failing to
3 timely file required interim reports; and section 260.241.3, subdivision (j), by failing to prepare and
4 maintain monthly computations of net capitals and aggregate indebtedness or of minimum net worth.

6 NOW, BASED UPON THE FOREGOING, AND GOOD CAUSE APPEARING, it is hereby
7 ORDERED, under the provisions of Corporations Code section 25249, that All Weather Portfolio
8 Management, Inc. immediately discontinue violating California Code of Regulations sections
9 260.237.1, subdivision (a)(2), 260.241.2, subdivision (a), 260.241.2, subdivisions (d)(2)(A)(1),
10 (d)(2)(B) and (d)(3), and 260.241.3, subdivision (j).
