Investment Law are not exclusive and may be sought and employed in any combination to enforce
the purpose and provisions of this law.

Respondents understand and agree that the Order remains in effect and is public, and that Respondents shall not make any statement or representation that is inconsistent with this Stipulation or the Order. Respondents further understand and agree that this Stipulation does not prevent the Commissioner from taking future action in regards to this matter.

6. Respondents agree that nothing in this Stipulation shall preclude the Commissioner, or her agents or employees, to the extent authorized by law, from assisting or cooperating in any investigation and/or action brought by any other federal, state or county agency. Respondents further agree that this Stipulation shall not bind or otherwise prevent any other federal, state or county agency from the performance of its duties.

7. Respondents enter into this Stipulation voluntarily and without coercion and acknowledge that no promises, threats or assurances have been made by the Commissioner or any officer, or agent thereof, about this Stipulation.
