DESIST AND REFRAIN ORDER  
(For violations of section 25110 of the Corporations Code)

The California Corporations Commissioner finds that:

1. At all relevant times, Robert Landeros was the President of Advanced Worldwide Security Solutions, Inc., a California corporation, doing business at 16134 Sherman Way, Van Nuys, California.
2. Advanced Worldwide Security Solutions, Inc. was formed in 2004 to be a “provider of Enterprise Security Management Systems that are designed for large enterprises to help them solve a diverse set of physical security and operational problems.”
3. Beginning in or about December 2006 and continuing thereafter, Advanced Worldwide Security Solutions, Inc. and Robert Landeros, individually and by and through salespersons, offered or sold securities in the State of California, in the form of stock in Advanced Worldwide Security Solutions, Inc. to California investors.
4. Advanced Worldwide Security Solutions, Inc. and Robert Landeros, individually and by and through salespersons called potential investors with whom they had no preexisting relationship and offered securities. The purpose of the offering was to raise \$6 million to be used for the existing infrastructure and acquiring other existing security companies.”

1 5. These securities were offered or sold in this state in issuer transactions. The Department of  
2 Corporations has not issued a permit or other form of qualification authorizing any person to offer or  
3 sell these securities in this state.

4 6. The Commissioner has not issued a permit or other form of qualification authorizing the offer  
5 and sale of the securities referred to herein in the state of California.

6 7. Advanced Worldwide Security Solutions, Inc. and Robert Landeros filed an exemption notice  
7 on August 2, 2006, however this exemption is void, due to the conduct of Advanced Worldwide  
8 Security Solutions, Inc. and Robert Landeros. The offer and sale of securities referred to herein were  
9 not exempt from the requirement of qualification under Section 25110.

10 Based upon the foregoing findings, the California Corporations Commissioner is of the  
11 opinion that the shares of stock in Advanced Worldwide Security Solutions, Inc. are securities subject  
12 to qualification under the California Corporate Securities Law of 1968 and are being or have been  
13 offered or sold without being qualified in violation of California Corporations Code section 25110.  
14 Pursuant to Section 25532 of the Corporate Securities Law of 1968, Advanced Worldwide Security  
15 Solutions, Inc. and Robert Landeros are hereby ordered to desist and refrain from the further offer or  
16 sale in the State of California of securities including but not limited to shares of stock in Advanced  
17 Worldwide Security Solutions, Inc., unless and until qualification has been made under this law or  
18 unless exempt.

19 This Order is necessary, in the public interest, for the protection of investors and consistent  
20 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
