25 January 25, 2017, Cantor Real Estate Finance Lending, LLC (Petitioner), filed with the  
26 Commissioner of Business Oversight (Commissioner) a petition for reinstatement of its California  
27 Finance Lenders Law (CFL) license. A copy of the petition is attached as Exhibit 1. The  
28 Commissioner had issued an order revoking Petitioner’s CFL license on December 8, 2015, because

1 it had failed to pay its annual assessment for 2015 to 2016 as required under Financial Code section
