24 On January 25, 2017, Cantor Real Estate Finance Lending, LLC (Petitioner), filed a Petition  
25 for Reinstatement of its California Finance Lenders Law (CFL) license, which the Commissioner of  
26 Business Oversight (Commissioner) had revoked on December 30, 2015, for failure to pay the 2015–  
27 2016 annual assessment as required under Financial Code section 22107. Included with the Petition  
28 was a payment for the 2015–2016 annual assessment.

1 On March 17, 2017, the Commissioner notified the Attorney General of the filing of the  
2 Petition and gave the parties until March 27, 2017, to present any written argument or supporting  
3 documentation. Neither party did so.

4 On March 28, 2017, the Commissioner granted the Petition for Reinstatement on the  
5 condition that Petitioner do the following within 30 days of the date of the order:

- 6 1. Pay a \$2,500.00 penalty.
- 7 2. Pay the \$250.00 annual assessment for 2016–2017.

8 The Commissioner finds that Petitioner has complied with all conditions for reinstatement of  
9 its license and is otherwise fit to engage in the business of finance lending or brokering.

10 THEREFORE, IT IS ORDERED that the Petition for Reinstatement is granted and  
11 Petitioner’s CFL license is reinstated, effective as of the date of this Order.
