25 Demetrios A. Boutris, the California Corporations Commissioner (“Commissioner”) of the  
26 Department of Corporations (“Department”) finds that:

27 Centennial Management (Francis Anthony Antonucci, DBA) (“CM”) has continued to  
28 violate the books and records requirements and the reporting requirements of the Corporate

1 Securities Law of 1968 (“CSL”)(Corp. Code § 25000 et seq.) and the regulations thereunder found at  
2 California Code of Regulations, title 10, (“CCR”) (§ 260.000 et seq.). CM has violated CSL section  
3 25241 and CCR sections 260.241.3(a) and 260.241.2(a) by failing to make and keep a general and  
4 auxiliary ledger accounting system reflecting asset, liability, reserve, capital, income, and expense  
5 accounts, and by failing to file required annual financial reports with the Commissioner within 90  
6 days of the end of its fiscal year.

7 NOW, BASED UPON THE FOREGOING, AND GOOD CAUSE APPEARING, it is hereby  
8 ORDERED under the provisions of Corporations Code section 25249, that Centennial Management  
9 (Francis Anthony Antonucci, DBA) immediately discontinue violating Corporations Code section  
10 25241 and California Code of Regulations sections 260.241.3(a) and 260.241.2(a).
