STIPULATED INJUNCTION RE MICHAEL
D'ANDREA

26 It is hereby stipulated as follows:

27 Michael D'Andrea, his agents, employees and all other persons acting in concert or
28 participating with him are hereby permanently enjoined from violating Corporations Code Section

1 25110, by directly or indirectly offering to sell or selling in this state any security unless such security
2 has been qualified under Sections 25111, 25112 or 25113 or unless such sale or transaction is
3 exempted or not subject to qualification under Chapter 1 of the Corporate Securities Law of 1968.

4 Michael D'Andrea, his agents, employees and all other persons acting in concert or
5 participating with him are hereby permanently enjoined from violating Corporations Code Section
6 25401, or aiding or abetting the violation thereof, by directly or indirectly offering to sell or selling in
7 this state by means of any written or oral communication any security which contains untrue
8 statements of any material fact or omits or fails to state any material fact necessary to make the
9 statements made, in the light of circumstances under which they were made, not misleading.

10 Michael D'Andrea, his agents, employees and all other persons acting in concert or
11 participating with him are hereby permanently enjoined from violating Corporations Code Section
12 31110, by directly or indirectly offering to sell or selling in this state any franchise unless such
13 security has been registered or is exempted under the Franchise Investment Law of California.

14 Michael D'Andrea, his agents, employees and all other persons acting in concert or
15 participating with him are hereby permanently enjoined from violating Corporations Code Section
16 31201, or aiding or abetting the violation thereof, by directly or indirectly offering to sell or selling in
17 this state any franchise by means of any written or oral communication which contains untrue
18 statements of any material fact or omits or fails to state any material fact necessary
19 to make the statements made, in the light of circumstances under which they were made, not
20 misleading.
