1 Defendants in Interpleader, and each of them, have sought to resolve the present matter by
2 entering into the Stipulation for Entry of Final Judgment (“Stipulation”) and this [Proposed] Final
3 Judgment (“Final Judgment”). Attached hereto as Exhibit 2 and incorporated herein by reference is a
4 true and correct copy of the parties’ Stipulation.

5 PURSUANT TO STIPULATION OF THE PARTIES AND GOOD CAUSE APPEARING
6 THEREFORE, IT IS HEREBY ORDERED, ADJUDGED AND DECREED THAT:

7 1. The interpleaded escrow trust funds in the amount of \$40,515.57, recovered from
8 Dependable Escrow Co. file number 5801350-MDR and deposited with the Court by Plaintiff in
9 Interpleader, the California Corporations Commissioner, on or about October 26, 2011, shall be paid
10 to Defendant in Interpleader the State of California Board of Equalization.

11 2. Upon receipt of an original copy of this order, the Clerk of the Los Angeles Superior
12 Court shall issue a draft for funds payable to the "State Board of Equalization" in the amount of
13 \$40,515.57.
