1 violated the books and records requirements under California Code of Regulations, title 10, sections
2 260.241.2, and 260.241.3. De La Motte violated California Code of Regulations, title 10, section
3 260.241.2, subdivision (a) by failing to file annual financial reports for years 1999 through 2002, and
4 California Code of Regulations, title 10, section 260.241.3, subdivision (a)(2) by failing to properly
5 maintain a general ledger.

6 NOW, BASED UPON THE FOREGOING, AND GOOD CAUSE APPEARING, it is hereby
7 ORDERED under the provisions of Corporations Code section 25249 that De La Motte immediately
8 discontinue those acts that were in violation of California Code of Regulations, title 10, sections
9 260.241.2, subdivision (a), and 260.241.3, subdivision (a)(2).
