25 Respondent, EMJ Capital Corporation (EMJ Capital) filed a written request petitioning for  
26 reinstatement (Petition) of its California Finance Lenders Law (CFLI) license with the  
27 Commissioner of Business Oversight (Commissioner). A true and correct copy of the Petition is

1 On December 8, 2015, the Commissioner issued an Order Summarily Revoking California
