25 Petitioner, Flagship Financial Group, LLC (“Flagship”), having filed a petition for
26 reinstatement of its California Finance Lender Law license, which was revoked by the
27 Commissioner of Corporations (“Commissioner”) on April 15, 2008 to be effective May 1, 2008,
28 the petition having been considered, no further argument submitted, and good cause appearing,

1 IT IS ORDERED that, subject to the Commissioner’s satisfactory review, the Petition for
2 Reinstatement is granted provided that the following conditions are met by Flagship within sixty
3 days (60) of the date hereof:

- 4 1. Payment of penalties to the Department of Corporations (“Department”) in the
5 amount of \$2,500 for failing to report the change in Flagship’s ownership to the Department.
- 6 2. Payment of penalties to the Department in the amount of \$2,500 for failing to file its
7 annual report.
- 8 3. Flagship is required to register the following branches with the Nationwide
9 Mortgage Licensing System and Registry (“NMLS”):
 - 10 a. 384 South 400 West Suite 100, Lindon, UT 84042
 - 11 b. 175 E. Warm Springs, Suite 200, Las Vegas, NV 89119
 - 12 c. 1050 Shiloh Road, Suite 304, Kennesaw, GA 30144
 - 13 d. 675 Hartz Drive, Suite 201, Danville, CA 94526
 - 14 e. 675 Hartz Drive, Suite 205, Danville, CA 94526
 - 15 f. 4055 South 700 East, Suite 205, Salt Lake City, UT 84107
- 16 4. Flagship is required to submit fingerprints to the Department for the managers of the
17 branches listed in sections 3(a)-(f) above.
- 18 5. The Department must receive fingerprint clearance from the Department of Justice
19 for Tauren-Ashlee Tucker prior to Reinstatement.
