IT IS ORDERED that, subject to the Commissioner's satisfactory review, the Petition for Reinstatement is granted provided that the following conditions are met by Grand Castle within thirty (30) days of the date hereof:

- 1. Payment of penalties in the amount of \$2,500 for failure to file its annual report for 2011.
- 2. Submission of a declaration signed by an officer of Grand Castle under penalty of perjury acknowledging that the license to be reinstated (i) is only a finance lender license and that Grand Castle will not engage in any brokering activity under the Finance Lenders Law unless and until Grand Castle files an application with the Commissioner to add brokering after the subject finance lender license has been reinstated, if it is reinstated; and (ii) is only for the office located at 667 Brea Canyon Road, Suite 24, Walnut, California 91789 and that Grand Castle will not engage in any finance lending activities at any other location unless and until Grand Castle files an application with the Commissioner to license additional location(s) after the subject finance lender license has been reinstated, if it is reinstated.
