10 **DESIST AND REFRAIN ORDER**
11 **(For violations of section 25110 of the Corporations Code)**

12 The California Corporations Commissioner finds that:

- 13 1. At all relevant times, Illegal Alien Partners, LLC is or was a Florida Limited Liability
14 Company, formed in July 2003.
- 15 2. At all relevant times, Illegal Alien Productions, LLC is or was a managing member
16 of Illegal Alien Partners, LLC.
- 17 3. At all relevant times Michael Hawn (“Hawn”) is or was President of Illegal Alien
18 Productions, LLC, and a managing member of Illegal Alien Partners, LLC.
- 19 4. Beginning in or about July 2003 and continuing to date, Hawn, Illegal Alien Partners,
20 LLC and Illegal Alien Productions, LLC have offered or sold securities in the form of shares
21 of limited liability interests in Illegal Alien Partners, LLC at \$5,000 per share in a \$1,200,000
22 offering.
- 23 5. Through solicitation of individuals over the internet at
24 www.illegalalienproductions.com, Hawn, Illegal Alien Partners, LLC and Illegal Alien
25 Productions, LLC are attempting to raise \$1,200,000 to provide working capital for financing
26 a feature length production for the direct-to-video market, of a science fiction movie, with a
27 working title of “Illegal Alien”.
- 28 6. These securities were offered or sold in this state in issuer transactions. The

1 Department of Corporations has not issued a permit or other form of qualification authorizing
2 any person to offer and sell these securities in this state.

3 Based on the foregoing findings, the California Corporations Commissioner is of the
4 opinion that the shares of limited liability interests in Illegal Alien Partners, LLC are
5 securities subject to qualification under the California Corporate Securities Law of 1968 and
6 are being or have been offered or sold without being qualified. Pursuant to Section 25532
7 of the Corporate Securities Law of 1968, Michael Hawn, Illegal Alien Partners, LLC, and
8 Illegal Alien Productions, LLC are hereby ordered to desist and refrain from the further offer
9 or sale in the State of California of securities in the form of shares of limited liability
10 interests, unless and until qualification has been made under said law. The sale of such
11 securities is subject to qualification under said law and such securities are being or have
12 been offered for sale without first being so qualified.

13 This Order is necessary, in the public interest, for the protection of investors and consistent
14 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
