22 In resolution of an investigation into unlawful practices in the offer and sale of securities in  
23 violation of California Corporations Code sections 25110 and 25401, and without admitting or  
24 denying such activities, IT IS HEREBY STIPULATED AND AGREED between Inner Image  
25 Diagnostics Limited Partnership, Capital Innovations, Inc. and Stanley Johnson (hereafter  
26 collectively "Respondents") and the California Corporations Commissioner ("Commissioner"), as  
27 follows:

1           1.       Without admitting or denying any of the findings, Respondents stipulate to the entry  
2 of the Desist and Refrain Order issued by the Commissioner on September 17, 2008 directing  
3 Respondents to desist and refrain from violations of the Corporate Securities Law of 1968.

4           2.       Respondents acknowledge that the Desist and Refrain Order was personally served on  
5 Stanley Johnson, individually and on behalf of Inner Image Diagnostics Limited Partnership and  
6 Capital Innovations, Inc. on October 30, 2008.

7           3.       Respondents withdraw their request for hearing on the allegations set forth in the  
8 Desist and Refrain Order. Respondents acknowledge their right to an administrative hearing under  
9 Corporations Code section 25532 and hereby waive their right to any hearing or appeal of the Desist  
10 and Refrain Order.

11          4.       Respondents agree that nothing in this Stipulation shall limit the Commissioner's  
12 ability to investigate and prosecute violations of the Corporate Securities Law not addressed in the  
13 Desist and Refrain Order.

14          5.       Respondents agree that nothing in this Stipulation shall preclude the Commissioner,  
15 or his agents or employees, to the extent authorized by law, from assisting or cooperating in any  
16 investigation and/or action brought by any other federal, state or county agency. Respondents  
17 further agree that this Stipulation shall not bind or otherwise prevent any other federal, state or  
18 county agency from the performance of its duties.

19          6.       Respondents enter into this Stipulation voluntarily and without coercion and  
20 acknowledge that no promises, threats or assurances have been made by the Commissioner or any  
21 officer, or agent thereof, about this Stipulation.

22          7.       Respondents and the Commissioner agree that this Stipulation may be executed in  
23 one or more separate counterparts, each of which when so executed, shall be deemed an original.  
24 Such counterparts shall together constitute and be one and the same instrument.

25          8.       This Stipulation is entered into for the purpose of judicial economy and expediency,  
26 and to avoid the time and expense of a hearing and possible further court proceedings. The  
27 Commissioner finds that this Stipulation is necessary or appropriate in the public interest or for the

1 protection of investors and consistent with the purposes fairly intended by the policy and provisions  
2 of this law.
