Having considered the Petition, the Commissioner grants the Petition, provided that  
Petitioner complies with all the following conditions:

1. File with the Commissioner a current balance sheet as evidence of compliance with Lamb Energy Finance, LLC’s net worth as of March 31, 2018.
2. File with the Commissioner the 2014 Annual Report of Lamb Energy Finance, LLC.
3. File with the Commissioner a current surety bond for Lamb Energy Finance, LLC.
4. Pay a penalty of \$3,500.00 to the Commissioner for failing to file the 2014 Annual Report in violation of Financial Code section 22159.

The penalty must be made payable in the form of a cashier’s check or Automated Clearing House deposit to the Department of Business Oversight and transmitted to the attention of Accounting – Litigation, at the Department of Business Oversight, 1515 K Street, Suite 200, Sacramento, California 95814.
