1 This court having read and considered the application, memorandum of points and authorities,
2 complaint, declarations and exhibits, and all other evidence presented, and having heard arguments
3 of counsel, and good cause appearing therefor:

4 IT IS HEREBY ORDERED that Defendant Earl D. Anschultz ("Anschultz") and his partners,
5 successors in interest, agents, employees, attorneys in fact, and all persons acting in concert or
6 participating with him, be and hereby are enjoined from, directly or indirectly:

7
8 A. violating California Corporations Code section 25230 by acting as a financial consultant
9 or by acting in any other capacity where he makes recommendations or renders advice regarding
10 securities or manages portfolios of clients for a fee without a license;

11 B. violating California Corporations Code section 25235(b) by engaging in transactions,
12 practices or a course of business to defraud or deceive any client or prospective client;

13 C. violating the Desist and Refrain Order, dated April 26, 2001;

14 D. violating the Stipulated Bar Order issued on October 1, 2005; and

15 ~~E. removing, destroying, mutilating, concealing, altering, transferring, or otherwise~~
16 ~~disposing of, in any manner, any books, records, computer programs, computer files, computer~~
17 ~~printouts, correspondence, brochures, manuals, or other writings or documents of any kind as~~
18 ~~defined in California Evidence Code Section 250 relating to the transactions and course of conduct~~
19 ~~as alleged in the complaint, unless authorized by this Court.~~ SA

20 If Anschultz disobeys this Order of Preliminary Injunction, the Commissioner or the Court
21 may enforce it through a contempt hearing, which is a quasi-criminal proceeding.
