 24 The California Corporations Commissioner ("Commissioner") finds that:

25 1. On August 22, 2001, the Commissioner issued an Order To Discontinue Violations  
 26 Pursuant to California Financial Code section 50321 against LOANCITY.COM based upon the  
 27 Commissioner's findings during a regulatory examination commenced on March 5, 2001  
 28 that LOANCITY.COM had (i) commingled trust funds with general operating funds in violation of  
 California Financial Code section 50202(a), (ii) caused debit balances to exist in the trust account in

1 violation of California Code of Regulations, title 10, section 1950.314.6, (iii) used trust funds for  
2 operating activities in violation of California Financial Code sections 50202(b) and 50503(a)(1), and  
3 (iv) placed trust funds in an interest bearing account in violation of California Financial Code section  
4 50202(b).

5 2. On August 22, 2001, LOANCITY.COM was served with the Order To Discontinue  
6 Violations Pursuant to California Financial Code Section 17602, Notice of Intent to Make Order  
7 Final, Statement of Facts, and accompanying documents at its licensed location by way of certified,  
8 return-receipt mail.

9 3. On September 5, 2001, LOANCITY.COM filed its Notice of Defense requesting a  
10 hearing, which Notice of Defense was subsequently withdrawn by LOANCITY.COM on November  
11 27, 2001;

12 THEREFORE, pursuant to the provisions of California Financial Code section 50323, the  
13 Order to Discontinue Violations Pursuant to California Financial Code Section 50321 described in  
14 paragraph 1 above is hereby final.

15 NOW, BASED ON THE FOREGOING, LOANCITY.COM is hereby ORDERED under the  
16 provisions of California Financial Code sections 50321 and 50323, to immediately discontinue the  
17 violations set forth above.
