19 I, JAN LYNN OWEN, Commissioner of Business Oversight formerly known as the
20 California Corporations Commissioner (“Commissioner”), pursuant to Financial Code section
21 17630, do hereby substitute Corporations Examiner Kristie Jaynes, as conservator of the banking
22 and escrow records of Morris Escrow, Inc. (“Morris Escrow”) in place and instead of Corporations
23 Examiner Edgar Nunez.

24 Kristie Jaynes, as conservator, shall take possession of the banking and escrow records for
25 the protection of the escrow agent, the customers of the escrow agent, and the public.

26 Kristie Jaynes, as conservator, and pursuant to California Financial Code section 17630, shall
27 have all the rights, powers, and privileges of Morris Escrow, its officers and directors, and shall have
28 the same powers and rights as the Commissioner, while she is in possession of the banking and

1 escrow records of Morris Escrow. These rights, powers and privileges shall include all acts as are
2 necessary or expedient to collect, conserve and protect the banking and escrow records of Morris
3 Escrow.

4 As previously ordered, all expenses of the conservatorship shall be paid out of the assets of
5 Morris Escrow, if an shall exist, and shall be a lien thereon which shall be prior to any other lien.

6 This Order is effective on the date hereof and may be amended or terminated upon further
7 order of the Commissioner at any time.
