19 I, PRESTON DuFAUCHARD, California Corporations Commissioner, pursuant to Financial  
20 Code section 17630, do hereby appoint Corporations Examiner Mona Elsheikh, as Conservator of  
21 the trust account(s) and all bank and escrow records pertinent thereto of Morris Escrow, Inc.  
22 (“Morris Escrow”), including, but not limited to, all Morris Escrow trust account(s) on deposit with  
23 Comerica Bank, in order that she may take possession of the trust accounts and records for the  
24 protection of the escrow agent, the customers of the escrow agent, and the public.

25 The conservator, pursuant to Financial Code section 17630, shall have all the rights, powers,  
26 and privileges of Morris Escrow, its officers and directors, and shall have the same powers and rights  
27 as the California Corporations Commissioner, while she is in possession of the trust account(s) and  
28 pertinent bank and escrow records of Morris Escrow. These rights, powers and privileges shall

1 include all acts as are necessary or expedient to collect, conserve and protect the trust accounts and  
2 pertinent bank and escrow records of Morris Escrow, including (a) the collection, recovery and  
3 compromise of claims, deeds, property and rights in favor of or belonging to Morris Escrow  
4 regarding the trust account(s); (b) the execution of all deeds, conveyances, agreements, compliances  
5 and instruments of every kind and nature in connection with the trust accounts and pertinent bank  
6 and escrow records of Morris Escrow; (c) the employment of accountants and attorneys to the extent  
7 reasonably necessary; and (d) with prior consent of the California Corporations Commissioner, the  
8 institution, maintenance and defense of suits related to the affairs of Morris Escrow, the filing of  
9 petitions or applications in court or elsewhere with respect to the trust accounts and pertinent bank  
10 and escrow records of Morris Escrow, for all purposes.

11 All expenses of the Conservatorship shall be paid out of the assets of Morris Escrow, if any  
12 shall exist, and shall be a lien thereon which shall be prior to any other lien.

13 This Order is effective on the date hereof and may be amended or terminated upon further  
14 order of the California Corporations Commissioner.
