22 Under Government Code section 11522, the Attorney General is hereby notified that on  
23 April 17, 2017, NorthMarq Finance, L.L.C. (NorthMarq Finance), filed with the Commissioner of  
24 Business Oversight (Commissioner) a petition for reinstatement of its California Finance Lenders  
25 Law (CFL) license. A copy of the petition is attached as Exhibit 1. The Commissioner had issued  
26 an order revoking NorthMarq Finance’s CFL license on December 30, 2015, because it had failed  
27 to pay its annual assessment for 2015 to 2016 as required under Financial Code section 22107. The

1 order became effective on December 30, 2015. A copy of the revocation order is attached as Exhibit  
2 2.

3 The Attorney General and NorthMarq Finance are notified that written argument and any
