PRELIMINARY INJUNCTION

1 To defendant Tony M. Nava, Jr.:

2 This Court having read and considered the application, memorandum of points and  
3 authorities, complaint, declarations and exhibits, and all other evidence presented, and good  
4 cause appearing therefore:

5 YOU AND EACH OF YOU ARE HEREBY ORDERED TO SHOW CAUSE AT  
6 9:30 a.m on 8/29/06, or as soon thereafter as counsel may be heard  
7 in Department 85 of the above entitled Court, located at 111 N. Hill St., Los Angeles,  
8 California 90012 why you, your agents, servants, assigns and all those acting in concert with  
9 you, should not be restrained and enjoined pending trial of this action from:

- 10 A. violating Corporations Code section 25110 by offering and selling  
11 unqualified, non-exempt securities;
- 12 B. violating Corporations Code section 25401 by misrepresenting and/or  
13 omitting material facts in the offers and sales of securities;
- 14 C. violating Corporations Code section 25404 by altering and falsifying the  
15 Desist and Refrain Order issued by the Commissioner on March 1, 2006;
- 16 D. violating Desist and Refrain Orders issued by the Commissioner on December  
17 10, 2002 and March 1, 2006; and
- 18 E. withdrawing from any bank account or disposing of any real or personal  
19 property in his possession or control, which property, or assets were derived or emanated  
20 from directly, or indirectly, the sale and issuance of securities alleged in this action, without  
21 leave of the Court.

22 PENDING HEARING on the above Order to Show Cause, you, your agents,  
23 servants, assigns and all those acting in concert with you, ARE HEREBY RESTRAINED  
24 AND ENJOINED from:

- 25 **A.** violating Corporations Code section 25110 by offering and selling  
26 unqualified, non-exempt securities;
- 27 B. violating Corporations Code section 25401 by misrepresenting and/or  
28 omitting material facts in the offers and sales of securities;

1 C. violating Corporations Code section 25404 by altering and falsifying the  
2 Desist and Refrain Order issued by the Commissioner on March 1, 2006;

3 D. violating Desist and Refrain Orders issued by the Commissioner on ~~December~~  
4 ~~10, 2002~~ and March 1, 2006; and

5 E. withdrawing from any bank account or disposing of any real or personal  
6 property in his possession or control, which property, or assets were derived or emanated  
7 from directly, or indirectly, the sale and issuance of securities alleged in this action, without  
8 leave of the Court.

9 This Order to Show Cause and supporting papers shall be served on defendant no  
10 later than 8/16/06 by personal service Proof of service shall be filed  
11 and delivered in the manner provided by CCP §527.

12 The following briefing schedule shall apply: Any opposition papers to the OSC shall  
13 be filed <sup>in Sept. 85</sup> and served on plaintiff no later than 8/21/06 noon. Any reply papers to  
14 such opposition shall be filed and served on defendant no later than 8/23/06 4 p.m.
