ORDER APPOINTING DAVID PASTERNAK  
CONSERVATOR PURSUANT TO SECTION  
17630 OF THE CALIFORNIA FINANCIAL  
CODE

24 I, DEMETRIOS A. BOUTRIS, California Corporations Commissioner, pursuant to California  
25 Financial Code § 17630, do hereby appoint David Pasternak of the law firm of Pasternak,  
26 & Patton as Conservator of NLCS ESCROW SERVICES, INC. ("NLCS"), in order that he may take  
27 possession of the property, business and assets of said escrow agent for the protection of the escrow  
28 agent, the customers of the escrow agent, its creditors, and the public.

1 The conservator, pursuant to California Financial Code § 17630, shall have all the rights, powers,  
2 and privileges of NLCS, its officers and directors, and shall have the same powers and rights as the  
3 California Corporations Commissioner, while he is in possession of the property, business and assets  
4 of the escrow agent. These rights, powers and privileges shall include all acts as are necessary or  
5 expedient to collect, conserve and protect the escrow agent's assets, property and business including  
6 (a) the collection, recovery and compromise of claims, deeds, property and rights in favor of or  
7 belonging to the escrow agent; (b) the execution of all deeds, conveyances, agreements, compliances  
8 and instruments of every kind and nature in connection with the business, property or affairs of said  
9 escrow agent; (c) the employment of accountants and attorneys to the extent reasonably necessary;  
10 and (d) with prior consent of the California Corporations Commissioner, the institution, maintenance  
11 and defense of suits related to the affairs of the escrow agent, the filing of petitions or applications in  
12 court or elsewhere for all purposes.

13 All expenses of the Conservatorship shall be paid out of the assets of the licensee and shall be a  
14 lien thereon which shall be prior to any other lien.

15 This Order is effective on the date hereof and may be amended or terminated upon further order of  
16 the California Corporations Commissioner.
