RESCISSION OF DESIST AND REFRAIN ORDER

(For violations of sections 17200 and 17403 of the California Financial Code)

Pursuant to Section 17400 of the California Escrow Law (Financial Code Section 17000, et seq.), the California Corporations Commissioner (Commissioner) hereby rescinds its Desist and Refrain Order issued on May 2, 2005, as to Alexandre Opizzi only.

The Commissioner finds that the rescission of this Order as to Alexandre Opizzi is necessary and appropriate, in the public interest, and consistent with the purposes of the policy and provisions of the Escrow Law.

DESIST AND REFRAIN ORDER
(For violations of sections 17200 and 17403 of the California Financial Code)

The California Corporations Commissioner finds that:

1. Ist-services.com, Robert Fogerty, Internet Safe Trading, Inc. (ISPS), Internet Safe Trading Jungwirth GmbH & Co., and Alexandre Opizzi have engaged in the business of an escrow agent by advertising escrow services over the internet at www.ist-services.com from 2001 to the present as follows:

a) Ist-services.com represents on its website that the process works as follows: The buyer and seller agree to the terms of the transaction. The buyer pays Ist-services.com, which verifies the payment. Ist-services.com notifies the seller to ship its merchandise and then verifies that the buyer receives the shipment. The buyer accepts the goods. Ist-services.com then pays the seller and the transaction is complete.

1 b) Ist-services.com claims to protect both the buyer and the seller from fraud with this
2 process.

4 2. Neither Ist-services.com, Robert Fogerty, Internet Safe Trading, Inc. (ISPS), Internet Safe
5 Trading Jungwirth GmbH & Co., nor Alexandre Opizzi has been issued a license from the
6 Commissioner authorizing them to conduct business as an escrow agent, as required by California
7 Financial Code section 17200.

8
9 3. Neither Ist-services.com, Robert Fogerty, Internet Safe Trading, Inc. (ISPS), Internet Safe
10 Trading Jungwirth GmbH & Co., nor Alexandre Opizzi is exempt from the licensing requirements of
11 Section 17200.

12
13 4. Neither Ist-services.com, Robert Fogerty, Internet Safe Trading, Inc. (ISPS), Internet Safe
14 Trading Jungwirth GmbH & Co., nor Alexandre Opizzi has been issued a license from the
15 Commissioner authorizing them to use words indicating that they are in the escrow business, as
16 required by California Financial Code section 17403.

17
18 Based upon the foregoing findings, the California Corporations Commissioner is of the opinion that
19 Ist-services.com, Robert Fogerty, Internet Safe Trading, Inc. (ISPS), Internet Safe Trading Jungwirth
20 GmbH & Co., and Alexandre Opizzi and their officers, directors, partners, agents, employees and/or
21 servants are in violation of California Financial Code sections 17200 and 17403(a). Pursuant to
22 California Financial Code section 17416, Ist-services.com, Robert Fogerty, Internet Safe Trading,
23 Inc. (ISPS), Internet Safe Trading Jungwirth GmbH & Co., and Alexandre Opizzi are hereby ordered
24 to desist and refrain from engaging in the business of receiving escrows for deposit or delivery
25 without first obtaining a license from the Commissioner. Pursuant to California Financial Code
26 section 17403(b), Ist-services.com, Robert Fogerty, Internet Safe Trading, Inc. (ISPS), Internet Safe
27 Trading Jungwirth GmbH & Co., and Alexandre Opizzi are further ordered to immediately desist and
28 refrain from issuing, circulating, or publishing any advertisement by means of any communication,

1 including any website, or making use of or circulating any letterheads, billheads, blank notes, blank
2 receipts, blank escrow instructions, certificates, circulars, or any written or printed paper containing
3 any fictitious or corporate name or other words indicating that they are in the escrow business.

5 This Order is necessary, in the public interest, for the protection of investors and consistent with the
6 purposes, policies and provisions of the California Escrow Law. This order shall remain in full force
7 and effect until further order of the California Corporations Commissioner.
