2. Obsidian Financial Services, Inc. is licensed as a finance lender under the California Finance Lenders Law (CFLL) with license number 60DBO-49262 (Obsidian).

3. In accordance with Financial Code section 22159, CFLL licensees must file an annual report with the Commissioner by March 15th of each year (Annual Report).

4. On March 6, 2017, the Commissioner notified CFLL licensees of the March 15th deadline to file their annual reports by sending notice to the email address each CFLL licensee established pursuant to the Commissioner's Order on Electronic Communications, dated November 22, 2013.

5. As of March 22, 2017, Obsidian had not filed its Annual Report with the Commissioner. As a result, the Commissioner issued a notice letter to Obsidian on March 22, 2017, advising Obsidian that it should file its annual report by April 11, 2017 or else its license would be summarily revoked pursuant to Financial Code section 22715 (Notice Letter).

6. As of April 11, 2017, the Commissioner had not yet received Obsidian's Annual Report. As a result, on April 19, 2017, the Commissioner issued an order pursuant to Financial Code section 22715 immediately revoking the CFLL license of Obsidian (Revocation Order).

7. Obsidian had failed to check, on a daily basis, the email address it established pursuant to the Commissioner's Order on Electronic Communications, dated November 22, 2013, as prescribed by the order.

8. Upon receiving the Revocation Order, Obsidian promptly notified the Commissioner and requested a hearing on the Revocation Order.

9. On May 24, 2017, Obsidian submitted its Annual Report, which was due on 22 March 15, 2017.

23 10. On May 11, 2017, Obsidian updated its email address it had established with the 24 Commissioner.

25 11. In connection with these proceedings, Obsidian represented to the Commissioner 26 that it had not conducted activity under its license following issuance of the Revocation Order.

27 12. In reliance upon these facts, on May 25, 2017, the Commissioner issued an order 28 rescinding the earlier Revocation Order.

## CITATION

Financial Code section 22707.5, subdivision (a), provides in relevant part:

(a) If, upon inspection, examination, or investigation, the commissioner has cause to believe that a licensee or other person is violating any provision of this division or any rule or order thereunder, the commissioner or his or her designee, may issue a citation to the licensee or person in writing, describing with particularity the basis of the citation . . . In addition, each citation may assess an administrative fine not to exceed two thousand five hundred dollars (\$2,500) . . . .

Based on the foregoing, Obsidian failed to file an annual report with the Commissioner by March 15, 2017 in violation of Financial Code section 22159. The Commissioner hereby assesses Obsidian an administrative fine of \$1,500.00 pursuant to Financial Code section 22707.5, subdivision (a). Obsidian is hereby ordered to pay the Commissioner an administrative fine of \$1,500.00 for the above citation within 30 days from the date of this citation.

Based on the foregoing, Obsidian failed to maintain its books, accounts and records in accordance with good business practice in violation of section 1426 of Title 10 of the California Code of Regulations. The Commissioner hereby assesses Obsidian an administrative fine of \$1,500.00 pursuant to Financial Code section 22707.5, subdivision (a). Obsidian is hereby ordered to pay the Commissioner an administrative fine of \$1,500.00 for the above citation within 30 days from the date of this citation.

Obsidian shall pay these fines with a cashier's check made payable to the Department of Business Oversight for the amount of \$3,000.00 and shall submit that check to the following address within thirty (30) days from the date of this citation: ATTN: Accounting – Litigation, Department of Business Oversight, 1515 K Street, Suite 200, Sacramento, California 95814. Notice of the payment shall be sent to: Adam Wright, Senior Counsel, Department of Business Oversight, 320 W. 4th Street, Suite 750, Los Angeles, California 90013.
