**DESIST AND REFRAIN ORDER**  
**(For violations of section 25110 of the Corporations Code)**

The California Corporations Commissioner finds that:

1. Outersphere LLC is a California Limited Liability Company with its principal office listed with California’s Secretary of State as 1910 Olympic Blvd, Ste. 151, Walnut Creek, California. At times most relevant to this order, at least one of its controlling persons has been Yvonne E. Gamble.

2. Yvonne E. Gamble (“Gamble”) is a controlling person of Outersphere LLC, as well as a controlling person of Outersphere Investment Group, LLC. Other members, managers or partners of Outersphere LLC include Fredrick C. Gamble, Michael Brinskele, and Nancy Mims. Other members, managers or partners of Outersphere Investment Group include Frederick C. Gamble and Floyd W. Watson.

3. Gamble and Outersphere LLC are believed to have raised money by the issuance of securities in the form of so-called “promissory notes” issued by Outersphere LLC. These were offered and sold at seminars, public presentations and by other forms of general solicitation. At least some of these notes promised a return of 6% per month for 36 months, at the end of which term the entire principal was to become due. Investors were told the money was being raised to finance the business plan of Outersphere Communications.

4. Outersphere Communications is an entity whose legal nature is not certain, and is not currently registered with California’s Secretary of State. Its website at [www.osicomm.com](http://www.osicomm.com) describes

1 it as a company providing Internet Protocol-based communications services to businesses. Its  
2 corporate management is listed as Gamble, Fredrick C. Gamble and Floyd W. Watson.

3 5. Investors in the above-described promissory notes have not received all promised  
4 payments and have not received return of their original investments.

5 6. The above-described securities have been offered and sold in California in issuer  
6 transactions. The Department of Corporations has not issued a permit or other form of qualification  
7 authorizing any person to offer and sell these securities in this state.

8 Based upon the foregoing findings, the California Corporations Commissioner is of the  
9 opinion that the investments offered and sold by Yvonne E. Gamble and Outersphere LLC are  
10 securities in the form of promissory notes and/or investment contracts and are subject to qualification  
11 under the California Corporate Securities Law of 1968, and that these securities have been offered  
12 and sold without being qualified in violation of Corporations Code section 25110 and are not exempt.  
13 Pursuant to section 25532 of the Corporate Securities Law of 1968, Yvonne E. Gamble and  
14 Outersphere LLC are hereby ordered to desist and refrain from the further offer or sale in the State of  
15 California of securities, including but not limited to promissory notes and/or investment contracts,  
16 unless and until qualification has been made under the law or unless exempt.

17 This Order is necessary, in the public interest, for the protection of investors and consistent  
18 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
