Re: Business License Agreement with Paradise Biryani Express, Inc.

You and Paradise Biryani Express, Inc. doing business as Paradise Biryani Pointe (PBP) entered into a Business License Agreement (the Contract) in \_\_\_\_\_, which granted you the right to operate a Paradise Biryani Pointe in \_\_\_\_\_, California.

The Commissioner of the California Department of Business Oversight (DBO) has determined that this Contract was a franchise under the California Franchise Investment Law. Under the terms of a Stipulation (a full copy of which is enclosed) we have reached with the DBO, you may choose ONE of the following options:

1. You may rescind the Contract, in which case you and PBP will be released of all contractual obligations and you will be refunded all license/franchise fees, training fees, advertising fees, recurring monthly fees, and license renewal fees paid at any time up through the execution of the Stipulation. If you elect to rescind the Contract, your relationship with PBP would end and you must cease operating under the PBP brand, discontinue any and all use of the PBP trademarks, including the removal of all signage, and return all manuals and other proprietary information to PBP.

**OR**

2. You may continue to develop and/or operate your PBP under the Contract.

Under the settlement with the DBO, you must give PBP notice of your decision within **90 days** after you receive this letter. If you do not you give PBP notice of your decision within 90 days after you receive this letter, you will be presumed to have chosen Option #2 above, to continue to develop and/or operate your PBP store under the Contract. Accordingly, please complete, sign and date the **Decision Regarding Rescission** below and return this letter to PBP in the enclosed envelope within 90 days after you receive this letter.
