main office of Prime West Escrow, Inc. ("Prime West") located at 8560 W. Sunset Boulevard, Suite 400, Los Angeles, California 90069, including, but not limited to, the Prime West trust account(s) at City National Bank, which account(s) include indemnity funds paid by Escrow Agent's Fidelity Corporation to Prime West, or any other bank holding trust funds of the main office ("main office trust property"), in order that he may take possession of the main office trust property for the protection of the escrow agent, the customers of the escrow agent, and the public.

1 The conservator, pursuant to Financial Code section 17630, shall have all the rights, powers, 2 and privileges of Prime West, its officers and directors, and shall have the same powers and rights as 3 the California Corporations Commissioner, while he is in possession of the main office trust 4 property of Prime West.
