1 THE CALIFORNIA CORPORATIONS COMMISSIONER ("Commissioner") finds that:

2 1. Respondent Quick Loan Funding, Inc. ("Quick Loan Funding") is a California Finance
3 Lender licensed by the California Corporations Commissioner ("Commissioner") pursuant to the
4 California Finance Lenders Law (Financial Code, § 22000, *et seq.*) ("CFL"). Quick Loan Funding
5 has its principal place of business located at 535 Anton Boulevard, Suite 600, Costa Mesa, California
6 92626.

7 2. Pursuant to Financial Code section 22159, Quick Loan Funding is required to file an
8 Annual Report and Addendum ("Annual Report") on or before the 15th day of March of each year for
9 the preceding 12-month period ended December 31st.

10 3. On March 15, 2008, Quick Loan Funding's Annual Report for the year ended
11 December 31, 2007 was due to the Commissioner as required by Financial Code section 22159.
12 Quick Loan Funding failed to submit the Annual Report by March 15, 2008.

13 4. On April 1, 2008, a letter was sent to Quick Loan Funding at its address of record,
14 demanding that the Annual Report be filed not later than April 11, 2008. Quick Loan Funding was
15 notified in the letter that failure to file the Annual Report would result in the summary revocation of
16 its license pursuant to Financial Code section 22715.

17 5. On May 13, 2008, a further letter was sent to Quick Loan Funding at its address of
18 record, demanding that it submit its Annual Report not later than May 23, 2008 and again notifying
19 Quick Loan Funding that failure to file the Annual Report by May 23, 2008 would result in the
20 summary revocation of its license pursuant to Financial Code section 22715.

21 6. Quick Loan Funding has yet to submit the Annual Report as required by Financial
22 Code section 22159.
