**DESIST AND REFRAIN ORDER**  
**(For violations of section 25110 and 25401 of the Corporations Code)**

The California Corporations Commissioner finds that:

1. At all relevant times, Argyle IP Networks, LLC (Argyle), was a Nevada corporation, with its principle place of business located at P.O. 9693 Fresno, California 93793, and in the business of brokering telephone traffic between the United States and Mexico.

1 2. At all relevant times, OnNet International Communications, LLC (OnNet) was a Nevada  
2 corporation with its principle place of business being 723 South Casino Center Blvd., 2nd Floor, Las  
3 Vegas, Nevada 89101.

4  
5 3. At all relevant times, OnNet was the parent company of Argyle.

6  
7 4. At all relevant times, Larry D. Gobel was the manager of Argyle, and in this capacity was  
8 responsible for the activities of the company.

9  
10 5. At all relevant times, Pedro Ortiz was a member of Argyle and in that capacity was  
11 responsible for the activities of the company.

12  
13 6. At all relevant times, Curtis Rojas was a member of OnNet International Communications,  
14 LLC, and in that capacity was responsible for the activities of OnNet.

15  
16 7. Beginning in or about May 2004, Argyle, Larry D. Gobel, Pedro Ortiz, offered or sold  
17 securities in the State of California, in the form of membership interests in Argyle representing a  
18 fractionalized interest in the company. These membership interests were offered or sold in California  
19 to a New York investor. The purpose of this offering was to raise a maximum of 10% interest in the  
20 company for operating funds.

21  
22 8. Beginning in or about October 2004, OnNet, Larry D. Gobel, and Curtis Rojas, offered or  
23 sold securities in the State of California, in the form of membership interests in OnNet representing a  
24 fractionalized interest in the company. These membership interests were offered or sold in California  
25 to a New York investor. The purpose of this offering was to raise money for operating funds.

1 9. These securities were offered or sold in this state in issuer transactions. The Department of  
2 Corporations has not issued a permit or other form of qualification authorizing any person to offer or  
3 sell these securities in this state.

4  
5 10. Respondents represented to investors that their membership interests would earn a set rate of  
6 return and that investors could receive their principle back in one year. The New York investor did  
7 not receive a fixed rate of return nor did he receive his principle back in one year.

8  
9 Based upon the foregoing findings, the California Corporations Commissioner is of the  
10 opinion that the membership interests issued by Argyle IP Networks, LLC, OnNet International  
11 Communications, LLC, Larry D. Gobel, Curtis Rojas, and Pedro Ortiz, are securities subject to  
12 qualification under the California Corporate Securities Law of 1968 and are being or have been  
13 offered or sold without being qualified in violation of Corporations Code section 25110. Pursuant to  
14 section 25532 of the Corporate Securities Law of 1968, Argyle IP Networks, LLC, OnNet  
15 International Communications, LLC, Larry D. Gobel, Curtis Rojas, and Pedro Ortiz, are hereby  
16 ordered to desist and refrain from the further offer or sale of securities in the State of California,  
17 unless and until qualification has been made under the law or unless exempt.

18  
19 Further, the California Corporations Commissioner is of the opinion that the securities were  
20 offered or sold in this state by means of written or oral communications which included an untrue  
21 statement of a material fact or omitted to state a material fact necessary in order to make the  
22 statements made, in the light of the circumstances under which they were made, not misleading, in  
23 violation of section 25401 of the Corporations Code. Pursuant to section 25532 of the Corporations  
24 Code, Argyle IP Networks, LLC, OnNet International Communications, LLC, Larry D. Gobel, Curtis  
25 Rojas, and Pedro Ortiz, are hereby ordered to desist and refrain from offering or selling or buying or  
26 offering to buy any security in the State of California, including but not limited to membership  
27 interests, by means of any written or oral communication which includes an untrue statement of a

1 material fact or omits to state a material fact necessary in order to make the statements made, in the  
2 light of the circumstances under which they were made, not misleading.

3

4 This Order is necessary, in the public interest, for the protection of investors and consistent  
5 with the purposes, policies, and provisions of the Corporate Securities Law of 1968. This order shall  
6 remain in full force and effect until further order of the California Corporations Commissioner.
