DESIST AND REFRAIN ORDER
(For violations of sections 25110 of the Corporations Code)

The California Corporations Commissioner finds that:

1. At all relevant times, Solid Land MAS Corporation (“Solid Land MAS”) is or was a corporation with its principal place of business located at 5800 South Eastern Avenue, Suite 270, Commerce, CA 90040-4019, and doing business in California.
2. At all relevant times, Raul Gonzalez (“Gonzalez”), and Robert Moreno (“Moreno”) are representatives of Solid Land MAS doing business in California.
3. Beginning in or about 2007, Solid Land MAS, Gonzalez and Moreno offered and sold securities in the form of promissory notes or investment contracts. Pursuant to the terms of these promissory notes or investment contracts, a California investor would pay to Solid Land MAS a lump sum of capital between \$500.00 to \$10,000.00 for the purpose of investing in various investment opportunities, including but not limited to real estate ventures, in exchange for a monthly profit on the capital invested.
4. These promissory notes or investment contracts were offered and sold in California in issuer transactions. The Department of Corporations has not issued a permit or other form of qualification authorizing any person to offer and sell these promissory notes or investment contracts in California.

1 Based on the foregoing findings, the California Corporations Commissioner finds that the
2 promissory notes or investment contracts sold by Solid Land MAS, Gonzalez and Moreno are
3 securities subject to qualification under the California Corporations Code. These securities are or
4 were offered and sold without being qualified or exempt, in violation of Section 25110 of the
5 California Corporations Code.

6 Pursuant to section 25532 of the California Corporations Code, Solid Land MAS Corporation,
7 Raul Gonzales, and Roberto Moreno are hereby ordered to desist and refrain from the further offer or
8 sale in the State of California of securities, including promissory notes or investment contracts, unless
9 and until qualification has been made under said law or unless exempt.

10 This Order is necessary, in the public interest, for the protection of investors and consistent
11 with the purposes, policies, and provisions of the California Corporations Code.
