Based on the findings contained in the Statement and the Citation, the Commissioner has determined that an order should be issued pursuant to Corporations Code section 31115(a) denying the effectiveness of the franchise renewal registration application submitted by Toms Franchise, LLC, and Do Kyun Kim.

NOW GOOD CAUSE APPEARING THEREFORE, it is hereby ordered that effectiveness of Toms Franchise, LLC, and Do Kyun Kim’s franchise renewal registration application filed with the Commissioner on September 14, 2015, is hereby denied. This order is necessary, in the public interest, for the protection of investors and franchisees, and consistent with the purposes, policies, and provisions of the California Franchise Investment Law.
