16 **DESIST AND REFRAIN ORDER**
17 **(For violation of section 25110 of the Corporations Code)**

18 The Commissioner of Business Oversight finds that:

- 19 1. At all relevant times, Tycoon Energy, Inc., and Tycoon Energy and Operating Company, Inc.
20 (herein “Tycoon”) are or were corporations with a principal place of business located at 555 Republic
21 Drive, Suite 100, Plano, Texas, 75074-5481, and doing business in California. Tycoon conducts
22 business by way of telephone number (972) 422-7555, facsimile number (972) 422-7557, email
23 address info@tycoonenergy.com, and by internet website address www.tycoonenergy.com. Matt
24 Nerbonne a.k.a. Mathew Nerbonne (“Nerbonne”) is the president and representative of Tycoon.
25 Donald Amacker (“Amacker”) is the vice president and also a representative of Tycoon.
- 26 2. At all relevant times, Tycoon-Lewis Prospect and Plains Ranch Prospect (collectively,
27 “Prospects”) are projects by Tycoon involving a series of wells producing oil from fields located in or
28 about Lubbock County, Texas. Tycoon-Lewis Well No.1 Joint Venture and Plains Ranch Well No. 3
Joint Venture (collectively, “Wells”) are specific oil well ventures which are part of and located in
the Prospects.
3. Beginning in July 2012, Tycoon, Nerbonne, and/or Amacker offered or sold securities in the
form of interests in the Prospects and Wells. The purported purpose of offering the interests was to
fund the above-described oil wells.

1 4. These securities were offered or sold in California in issuer transactions. The Department of
2 Business Oversight has not issued a permit or other form of qualification authorizing any person,
3 including but not limited to Matt Nerbonne a.k.a. Mathew Nerbonne, Donald Amacker, Tycoon
4 Energy, Inc., or Tycoon Energy and Operating Company, Inc. to offer and/or sell these securities in
5 California.

6 Based on the foregoing findings, the Commissioner of Business Oversight finds that the
7 interests offered and/or sold by Matt Nerbonne a.k.a. Mathew Nerbonne, Donald Amacker, Tycoon
8 Energy, Inc., or Tycoon Energy and Operating Company, Inc. are securities subject to qualification
9 under the Corporations Code. These interests are or have been offered or sold without being
10 qualified or exempt, in violation of Corporations Code section 25110.

11 Pursuant to Corporations Code section 25532, Matt Nerbonne a.k.a. Mathew Nerbonne,
12 Donald Amacker, Tycoon Energy, Inc., or Tycoon Energy and Operating Company, Inc. are hereby
13 ordered to desist and refrain from the further offer or sale in California of securities, including, but
14 not limited to interests, unless and until qualification has been made under said law or unless exempt.

15 This Order is necessary, in the public interest, for the protection of investors and consistent
16 with the purposes, policies, and provisions of the Corporations Code.
