**DESIST AND REFRAIN ORDER**  
**(For violations of section 25110 of the Corporations Code)**

The California Corporations Commissioner finds that:

1. At all relevant times, Green Medica Holding Corp. (hereinafter, “the Corporation”) was a Nevada corporation, formed on June 23, 2008. The Corporation’s current status in Nevada is “default.” The California Secretary of State recognizes Green Medica Holdings Corp. as an active Nevada corporation. The Corporation is a nutritional supplement company that produces and sells “Brain Rescue” and “Coriolus Versicolor” nutritional products. The Corporation’s principal place of business is 24328 S. Vermont Ave., Harbor City, CA 90710.
2. Green Medica, LLC, (hereinafter, “the LLC”) is an active California limited liability company formed on November 7, 2006. The LLC’s principal place of business is also 24328 S. Vermont Ave., Harbor City, CA 90710. The LLC is a wholly owned subsidiary of the Corporation.
3. Jose L. Pardo aka Joe Pardo (herinafter, “Pardo”) is a natural person and a resident of California. Pardo is the President of the Corporation and the Chief Operating Officer of the LLC. His business address is also 24328 S. Vermont Ave., Harbor City, CA 90710
4. John R. Munoz aka J. R. Munoz (hereinafter, “Munoz”) is a natural person and a resident of California. Munoz is employed by the Corporation and/or the LLC and shares the same address.

1 5. Brian V. Vogel (hereinafter, "Vogel") is a natural person and a resident of California. At all  
2 relevant times, he was an officer and director of the Corporation, although he is no longer associated  
3 with the Corporation or the LLC.

4 6. Beginning in or about November 2008 through July 2010, the Corporation, the LLC, Pardo,  
5 Munoz, and Vogel offered and sold securities in the form of convertible notes and stock in the  
6 Corporation in and from the State of California to at least 12 persons.

7 7. The Department of Corporations has not issued a permit or other form of qualification  
8 authorizing any person to offer and sell these securities in this state.

10 Based upon the foregoing findings, the California Corporations Commissioner is of the opinion  
11 that the convertible notes and stock offered and sold by Green Medica Holding Corp., Green Medica,  
12 LLC, Jose L. Pardo aka Joe Pardo, John R. Munoz aka J. R. Munoz, and Brian V. Vogel are securities  
13 subject to qualification under the California Corporate Securities Law of 1968 and are being or have  
14 been offered and sold without being qualified in violation of Corporations Code section 25110.

15 Pursuant to section 25532 of the Corporate Securities Law of 1968, Green Medica Holding  
16 Corp., Green Medica, LLC, Jose L. Pardo aka Joe Pardo, John R. Munoz aka J. R. Munoz, and Brian  
17 V. Vogel, and any associates, partners, or affiliate companies, are hereby ordered to desist and refrain  
18 from the further offer or sale in the State of California of securities, including but not limited to  
19 convertible notes and stock, unless and until qualification has been made under the law or unless  
20 exempt.

21 This Order is necessary, in the public interest, for the protection of investors and consistent  
22 with the purposes, policies, and provisions of the Corporate Securities Law of 1968.
