24 Wayne Strumpfer, the Acting California Corporations Commissioner of the Department of
25 Corporations finds that:

26 Verona Capital Management, LLC has continued to violate the books and records
27 requirements of the Corporate Securities Law of 1968 (Corporations Code section 25000 et seq.) and
28 the regulations enacted thereunder. Verona Capital Management, LLC has violated California Code

1 of Regulations, title 10, section 260.241.3 subdivision (a)(2) by failing to maintain general and
2 auxiliary ledgers. In addition, VCM violated California Code of Regulations, title 10, section
3 260.241, subdivision (j) by failing to prepare and maintain monthly trial balances and computations
4 of net capital and aggregate indebtedness or of minimum net worth. Verona Capital Management,
5 LLC has also violated California Code of Regulations, title 10, section 260.241.2, subdivision (a) by
6 failing to file annual financial reports with the Commissioner.

7 NOW, BASED UPON THE FOREGOING, AND GOOD CAUSE APPEARING, it is hereby
8 ORDERED under the provisions of Corporations Code section 25249, that Verona Capital
9 Management, LLC immediately discontinue violating California Code of Regulations, title 10,
10 section 260.241.3, subdivisions (a)(2) and (j) and section 260.241.2, subdivision (a).
